

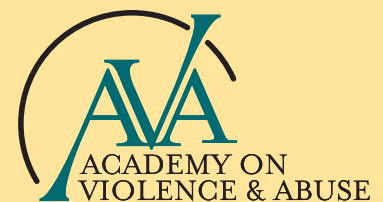

Robert Block, MD, FAAP

Robert W. Block, MD, FAAP, is immediate past president of the American Academy of Pediatrics (AAP). Dr. Block is also a Professor of Pediatrics and immediate past Daniel C. Plunket Chair, Department of Pediatrics, The University of Oklahoma School of Community Medicine in Tulsa.

Dr. Block received his M.D. degree from the University of Pennsylvania, and completed his pediatric residency at the Children's Hospital of Philadelphia. He has been a member of the O.U. College of Medicine faculty since 1975. As a faculty member, Dr. Block has been nominated for the Aesculapian teaching award six times, winning on three occasions. Dr. Block has been awarded the prestigious Stanton L. Young Master Teacher Award, a University of Oklahoma Presidential Professorship, the Accreditation Council for Graduate Medical Education Parker J. Palmer "Courage to Teach" Award, the Ray Helfer Society Award in recognition of his work in the field of Child Abuse, and the Award for Outstanding Service to Maltreated Children by the American Academy of Pediatrics. In 2001 and subsequently, he has been named one of the "Best Doctors in America." He was appointed the first Chair of the newly formed subboard on Child Abuse Pediatrics by the American Board of Pediatrics from 2006-2009, and continues serving on the subboard. He holds Certificate #1 from the ABP in Child Abuse Pediatrics.



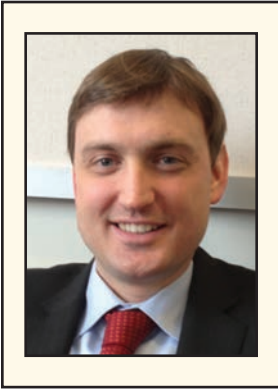
Risa Breckman, LCSW

A licensed clinical social worker, Ms. Breckman is an Assistant Professor of Gerontological Social Work in Medicine and Director of Social Work Programs and Education in the Division of Geriatrics and Gerontology at Weill Cornell Medical College. Since 1982, she has been at the forefront of developing protocols, educational forums and materials on elder abuse and neglect and teaching practicing physicians, other health care providers, and social service workers throughout the US and Canada about this issue. She developed the 3-day training currently used by NYC-Department for the Aging and conducts trainings for their elder abuse specialists.

A co-author of the American Medical Association's Diagnostic and Treatment Guidelines on Elder Abuse and Neglect, Ms. Breckman is also the co-author of the seminal book guiding interventions, *Strategies for Helping Victims of Elder Mistreatment* (1988) and numerous other publications addressing this topic. She has been developing a geriatrics psychosocial screening tool for use in the primary care setting which can help health care practitioners identify a range of social and psychological problems in the older population, including elder abuse. She developed the award-winning, geriatric psychosocial Web site, CornellCARES.com, which includes educational and resource materials for practitioners to use when helping abuse victims. Currently, Ms. Breckman is working with the Cornell Institute for Translational Research on Aging to bring practitioners and researchers together to develop an elder abuse research agenda for New York City.

David P.R. Burnes, PhD Candidate, MSW

David P.R. Burnes, a PhD candidate at the Columbia University School of Social Work with specialization in gerontology and elder abuse/neglect, is a Social Science and Humanities Research Council Canada Fellowship scholar. His research focuses on elder abuse social service intervention development, evaluation and outcome measurement; elder abuse severity prevalence and risk factors; and psychometric scale development. He has completed a Bachelors of Science degree in Mathematics and a Masters of Social Work degree. As assistant director of the JASA Research Institute, David designs, implements and coordinates research projects associated with elder caregiver support interventions, elder abuse social service program evaluation and prediction of victim program outcomes, elder case management services, and adult protective services assessment strategies. David is a licensed clinical social worker and currently manages a psychotherapy practice specializing in assessment and treatment of those affected by posttraumatic stress disorder. Following completion of his PhD this coming year, David would like to pursue an academic career in research and teaching.



Jacquelyn Campbell, PhD, RN, FAAN

Jacquelyn Campbell, PhD, RN, FAAN is the Anna D. Wolf Chair and Professor, Johns Hopkins University School of Nursing with a joint appointment in the Bloomberg School of Public Health. She has been conducting advocacy policy work and research in the area of domestic violence since 1980. Dr. Campbell has been the PI of 10 major NIH, NIJ or CDC research grants and published more than 150 articles and seven books on this subject. She is an elected member of the Institute of Medicine and the American Academy of Nursing and on the Boards of Directors of the Family Violence Prevention Fund and the House of Ruth Battered Women's Shelter. She received the 2006 Friends of the National Institute of Nursing Research Pathfinder Award.



Michele Decker, ScD, MPH

Dr. Michele Decker is an Assistant Professor in the Department of Population, Family and Reproductive Health at the Johns Hopkins Bloomberg School of Public Health. Her research is centered around gender-based violence and its health impact, particularly that related to sexual risk, in the general population as well as groups that are uniquely marginalized. She has examined the social, economic, network and individual-level factors that place women at risk for gender-based violence and poor sexual and reproductive health, as well as a range of intervention models to reduce such risk. She has worked with women involved in sex work, including those trafficked for sexual exploitation, in a range of settings in the US and internationally. Informed by a social epidemiology framework, she blends qualitative methods with large-scale quantitative investigations.

Paul Grundy, MD, MPH

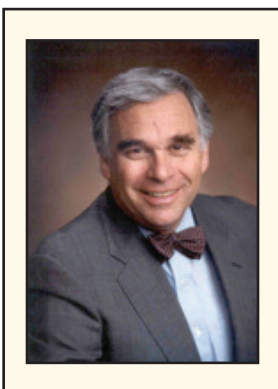
Paul Grundy, MD, MPH is IBM's Global Director of Healthcare Transformation and President of the Patient Centered Primary Care Collaborative. Dr. Grundy is known as the Godfather of the Patient Centered Medical Home and is one of only 38 IBMers and the only physician selected into IBM's senior industry leadership forum known as the IBM Industry Academy. Paul is a Member of the Institute of Medicine, Director, Accreditation Council for Graduate Medical Education (ACGME) and Professor at the University of Utah's Department of Family and Preventive Medicine.

Though he was born in Rhode Island, Paul's first language was Creole, which he learned growing up in Freetown, Sierra Leone. Founded with the help of his Quaker ancestors, Freetown was the home, for a time, of Paul's parents and grandparents. Dr. Grundy's advocacy on behalf of the medical home concept—including his leadership as president of the Patient-Centered Primary Care Collaborative—has helped medical homes spread and improve quality nationwide.



Lisa James, MS

Lisa James is Director of Health at Futures Without Violence (formerly Family Violence Prevention Fund). As part of the National Health Initiative on Domestic Violence, Ms. James has collaborated with health care providers, domestic violence experts and health policy makers in 20 states across the U.S. to develop statewide health care responses to domestic violence through training, health policy reform and public education. She collaborates with national medical and nursing associations to enact effective health policy and programmatic health care responses to abuse and coordinates the biennial National Conference on Health Care and Domestic Violence (attended by over 1000 participants).



Richard D. Krugman, MD

Richard D. Krugman, MD, is the first Vice Chancellor for Health Affairs for the University of Colorado Denver. In this role, he supports the deans of Dental Medicine, Nursing, Pharmacy, Public Health and the Graduate School for the Anschutz Medical campus and oversees all clinical programs of the University at its five affiliated hospitals. Along with overseeing clinical programs, the Center on Aging, the Center of Bioethics and Humanities, Colorado Area Health Education (AHEC) system, and Risk Management report to Dr. Krugman. Dr. Krugman became Dean of the University of Colorado School of Medicine on March 1, 1992, after serving as acting dean for 20 months.

As a professor of pediatrics, he served as Director of the C. Henry Kempe National Center for the Prevention and Treatment of Child Abuse and Neglect from 1981-1992, and has gained international prominence in the field of child abuse. He is also President of University Physicians, Inc., the CU School of Medicine faculty practice plan. Dr. Krugman is a graduate of Princeton University and earned his medical degree at New York University School of Medicine. A board-certified pediatrician, he did his internship and residency in pediatrics at the University of Colorado School of Medicine.

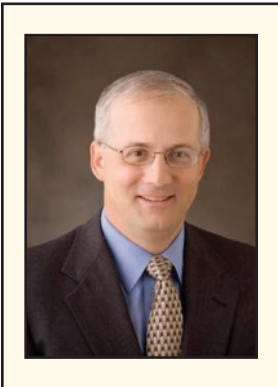

Laura Mosqueda, MD

Laura Mosqueda, M.D. is the Director of Geriatrics at the University of California, Irvine School of Medicine where she is also a Professor of Family Medicine and holds the Ronald W. Reagan Endowed Chair in Geriatrics.

In 2003 she founded the Orange County Elder Abuse Forensic Center located in Orange County, California. She has been the principal investigator on multiple grants focusing on elder mistreatment particularly in the areas of forensic markers, dementia, and education. She has extensive experience in the field with elder victims and interdisciplinary teams. She directs the Center of Excellence on Elder Abuse and Neglect at the University of California, Irvine (www.centeronelderabuse.org) which manages programs in practice, research, education, and advocacy.



Joseph N. Mott, FACHE

Joe Mott has a bachelor's degree in Economics and an MBA degree from Brigham Young University. He has worked for Intermountain Healthcare since 1985, including at Primary Children's Medical Center from 1992 to 2012. At Primary Children's, he served as CFO for 10 years and as CEO from 2007 to 2012. Throughout his tenure at Primary Children's, Joe spent much of his time and energy in quality improvement, patient safety, and making healthcare affordable.

In early 2011, Joe was asked to lead Intermountain's implementation of its Shared Accountability strategy and in February 2012, Joe was appointed Intermountain Healthcare's Vice President for Healthcare Transformation. In this role Joe coordinates the development and implementation of this strategy, which aims to improve quality while bringing the healthcare cost trend in line with general inflation.

Joe has served as the Chair of Child Health Quality Council for the National Association of Children's Hospitals and as Chairman of the Davis County Board of Health.



Frank W. Putnam, MD

Frank W. Putnam, MD is a Professor of Clinical Psychiatry at the University of North Carolina School of Medicine. He was formerly a Professor of Pediatrics and Child Psychiatry at Children's Hospital Medical Center, University of Cincinnati College of Medicine. Following completion of his residency in adult psychiatry at Yale University in 1979, Dr. Putnam joined the National Institute of Mental Health Intramural Research Program in Bethesda, Maryland, where he first encountered large numbers of adult patients who had been abused as children. This led him to complete a fellowship in child and adolescent psychiatry and to focus his research on the psychological, biological and social effects of child abuse.

In 1999, he became Director of the Mayerson Center for Safe and Healthy Children, which is dedicated to improving prevention, evaluation and treatment services for traumatized children and their families. The Center, which sees over 2000 children a year, has a strong research and training program focused on providing effective interventions for the complex, and often difficult, family situations associated with child abuse and neglect. Dr. Putnam is the author of over 160 scientific publications and 2 books on topics related to child abuse and neglect.

The Adverse Childhood Experiences Study (ACE Study) is the largest, replicated, and most influential study of the relationship between childhood adversity and later health status. It "changed the landscape" (Putnam, 2011) on how childhood adversity is viewed and studied. In early 2012, the Academy on Violence and Abuse released a new DVD that includes plenary addresses by Drs. Felitti, Anda and Putnam along with individual interviews of Felitti, Anda and David Williamson, PhD, the CDC obesity researcher who first introduced Felitti and Anda. This workshop will address what information the AVA ACE Study DVD contains and how to best use it for professional, policy maker and public education.
