


Building Compassionate Communities: Trauma Informed System of Care Conference

Speakers

David L. Corwin, MD -

Adverse Childhood Experiences informing best practices

Dr. Corwin is Professor and Director of Pediatrics' Forensic Services at the University of Utah Department of Pediatrics. He served as Medical Director of Primary Children's Center for Safe and Healthy Families from 1999 to 2012. He is board certified in Psychiatry, Child Psychiatry, and Forensic Psychiatry.

He is a co-founder of five professional societies addressing child maltreatment and other types of interpersonal violence: California and American Professional Societies on the Abuse of Children (CAPSAC and APSAC), the Ray Helfer Society, the Academy on Violence and Abuse (AVA), and the National Health Collaborative on the Violence and Abuse (NHCVA). He produced AVA's Adverse Childhood Experiences (ACEs) Study DVD (2012) and leads the ongoing development of AVA/NHCVA's "ACEs: Informing Best Practice" online document (2015). Dr. Corwin currently serves as the President of the APSAC. Dr. Corwin helped found Utah's Trauma-Resilience Collaborative in 2014 and joined the Steering Committee of Utah's Coalition for Protecting Childhood in March of 2016. He co-chaired the National Summit to End Corporal Punishment in the USA in October of 2017.

He consults, evaluates and testifies in legal cases involving child maltreatment and trauma throughout the US and lectures on these topics worldwide.

Machelle Madsen Thompson, Ph.D., LCSW -

Trauma Informed Schools Recognizing and Building Resiliency and Protective Factors

Dr. Thompson is the director of the Resilience & Protective Factor Initiative at Florida State University Multidisciplinary Center. Her research focuses on protective factors and interventions that increase resiliency with those who have experienced trauma. She teaches graduate courses including Social Policy, Diversity in Social Work Practice, Counseling Children & Adolescents, and Child Welfare Practice.

She has been an interventionist across 20 years focusing on counseling high-risk children, adolescents and families experiencing trauma, poverty, and abuse. Machelle is on the board of directors of the Academy on Violence and Abuse and presents internationally on the implementation of protective factors in school, counseling, foster care, medical, and high-risk community settings. She co-authored the Trauma Resilience Scale for Children, which has been used across the world. She conducted her measurement research for Asian children with National Children's Medical Center in Shanghai and with children living in poverty in Hong Kong as a Fulbright U.S. Scholar, 2018.

Susan Wiet, MD

Primary Care Integration, Trauma informed care for Substance Use Disorder and introducing the Health-Resiliency-Stress Questionnaire (HRSQ)

Susan is an integrative developmental psychiatrist with expertise in holistic treatment of trauma-addiction, dual diagnosis, and complex psychiatric disorders. She synthesizes functional medicine principles, honed therapeutic skills (trauma-informed, psychodynamic and EMDR trained), and allopathic medical training to provide comprehensive treatment for optimal healing and conservative use of medication.

Some highlights of Susan's career include: Trauma-Resiliency Collaborative

(founder and chair), Psychiatric Consultant (Clinics of Utah, Dept. of Health: Primary Care Integration Project), sequential Medical Directorships (University of Utah and community mental health organizations), and educator/presenter on trauma-resiliency and adolescent addiction.

She is Adjunct Volunteer Faculty at the University of Utah (UofU) Dept. of Psychiatry, Course-Director for Adolescent Addiction, and a member of the Alumni Board School of Medicine (UofU).

She graduated from Northwestern University Medical School (Chicago) and trained at the UofU in General Psychiatry and Child/Adolescent Psychiatry (fellowship). She holds three American Medical Board certifications: General Psychiatry, Child and Adolescent Psychiatry, and Addiction Medicine.

Victor Veith, JD

Trauma Informed Faith Community & Looking at a Trauma Informed Legal System

Victor is the Director of Education and Research for the Zero Abuse Project, President of the Academy on Violence and Abuse, and Founder of the Gundersen Nation Child Protection Training Center. He previously served as executive director of the National Center for the Prosecution of Child Abuse. Victor has trained thousands of child protection professionals from all 50 states, two U.S. Territories and 17 countries on numerous topics pertaining to child abuse investigation, prosecution, and prevention.

He is the recipient of numerous awards including the Pro Humanitate Award for Child Advocacy from the North American Child Resource Center for Child Welfare and the Heritage Service Award from the National Partnership to End Interpersonal Violence. He holds degrees from Winona State University, Hamline University School of Law, and Wartburg Theological Seminary

Shannon Robshaw, MSW

Trauma Informed Regional System of Care Planning- Next Steps

Shannon currently serves as the Senior Advisor for System Design and Implementation for the National TA Network for Children's Behavioral Health and the System Design and Implementation Coach for the National Wraparound Implementation Center.

She has more than 25 years of experience in state government and non-profit executive leadership positions focusing on policy and system reform to improve mental health and health service delivery systems. Since joining the TA Network for Children's Behavioral Health, University of Maryland in October 2013, Shannon has provided a range of technical assistance to more than 14 state level system of care grantees and 20 local community grantees. She previously served as Executive Director of the Continuum of Care in the South Carolina Governor's Office, Director of the Louisiana Coordinated System of Care, Executive Director of the Louisiana Health Care Quality Forum, an Executive Management Officer in the Office of the Secretary of the Louisiana Department of Health and Hospitals, and Executive Director of the Mental Health Association in Louisiana.
